


CASE MANAGEMENT & OPTIONS COUNSELING PROGRAM

SVCOA's case managers and options counselors served 1,351 older Vermonters in Rutland and Bennington counties this year, helping to empower clients to make important life decisions around various services and supports, and ultimately support and encourage their independence and quality of life.

HELPLINE

SVCOA'stoll-free, confidential and AIRS-certified (Alliance of Information and Referral Systems) HelpLine processed 5,746 calls this year, providing timely information, referrals

and assistance on community and statewide programs to older Vermonters in our service area.



NUTRITION PROGRAM

SVCOA served 208,834 meals to 2,875 older Vermonters

in our region this year, including 143,561 home delivered meals to 1,055 individuals and 65,273 community meals to 1,953 seniors. Additionally, SVCOA's nutrition assistant completed home-delivered meals and 3SquaresVT assessments for 631 area residents to ensure proper meal allocations and prioritization. The nutrition program also maintained its role as an integral community resource on nutrition education, providing nutrition counseling through our registered dietician to 78 individuals, group presentations to 125 people and a new cross-generational program, "The Grand Kitchen," to 16 participants including eight children and eight older guardians.

WELLNESS PROGRAM

SVCOA recently added a wellness component to its variety of offerings, one that is centered on the nationally-recognized and evidence-based program, "Tai Chi for Falls Prevention." This program is designed to engage older Vermonters in a series of

tai chi classes aimed at improving balance, strength and overall health. This year SVCOA saw approximately 200 people participate in the program via 18 classes that are held regularly by 22 volunteer instructors between Bennington and Rutland counties.

SENIOR COMPANION & VOLUNTEER PROGRAMS

Also helping older Vermonters remain independent in their own homes, SVCOA's Senior Companion Program assisted 80 individuals this year. From helping seniors with daily errands and tasks and providing general social companionship, to relieving family or

professional caregivers, SVCOA's 21 Senior Companions continued to make a difference in our area. Additionally, 108 SVCOA volunteers made significant contributions to both agency operations and the lives of our clients through their work on a variety of group and individual projects.



NATIONAL FAMILY CAREGIVER SUPPORT PROGRAM

SVCOA continues to support caregivers in our region through a range of informational and financial resources including our HelpLine, the Dementia Respite Grant Program, National Family Caregiver Support grants, and a variety of caregiver educational opportunities. During the past year, 754 caregivers participated in our numerous caregiver programs, and 49 grants were awarded to caregivers across Rutland and Bennington counties.



STATE HEALTH INSURANCE PROGRAM

The State Health Insurance Program (SHIP), which is designed to help individuals learn about and navigate Medicare, made 1,121 contacts this year in assisting older Vermonters with a variety of questions and issues related to Medicare, Medigap and Medicare Part D insurance benefits.

Included in these contacts were 69 coordinated informational workshops and classes which were attended by 690 people.

GREEN MOUNTAIN RETIRED SENIOR VOLUNTEER PROGRAM

Green Mountain Retired Senior Volunteer Program (GMRSVP), an SVCOAsponsored initiative, continued its work this year in recruiting and placing older Vermonters into volunteer opportunities where they can use their skills and experience to address vital community needs. Across Bennington, Windham and Windsor counties, GMRSVP administered 321 volunteers who provided 38,976 volunteer hours to vital causes across southern Vermont. Key outcomes of the program for GMRSVP's fiscal year include 1027 tax returns submitted on behalf

of those needing assistance; 827 food-insecure individuals served; 671 Bone Builder participants served; 150 Meals on Wheels recipients served; 356 rides provided by transportation volunteers; Friendly visits to five older Vermonters; and four individuals assisted by money management volunteers.

ELDER CARE CLINICIAN

SVCOA's Elder Care Clinicians, who are dedicated to supporting older Vermonters with mental health concerns that interfere with daily life, provided private counseling to 91 individuals in their own homes throughout our planning service area this year.



MONEY MANAGEMENT PROGRAM

SVCOA's money management program continued to provide financial support and assistance this year through both the fee-for-service Representative Payee offering and a no-cost bill payer assistance program supported by trained and bonded volunteers. The Representative Payee Program, which provides complete financial oversight for those who are unable to manage their own finances as determined by a physician, and approved by the Social Security Administration, served 131 clients this year. The bill payer assistance program, made possible by the assistance of four energetic volunteers, provided support to 16 additional clients.

TRANSPORTATION

SVCOA continues to assist older Vermonters and disabled individuals with transportation needs in Bennington and Rutland counties through financial support of the One-2-One volunteer transportation program, Bennington Project Independence Adult Day Center, and Green Mountain Express, as well as collaboration with Marble Valley Regional Transit District. Collectively, these organizations provided 29,930 rides this year to both seniors and individuals with disabilities in our area.
